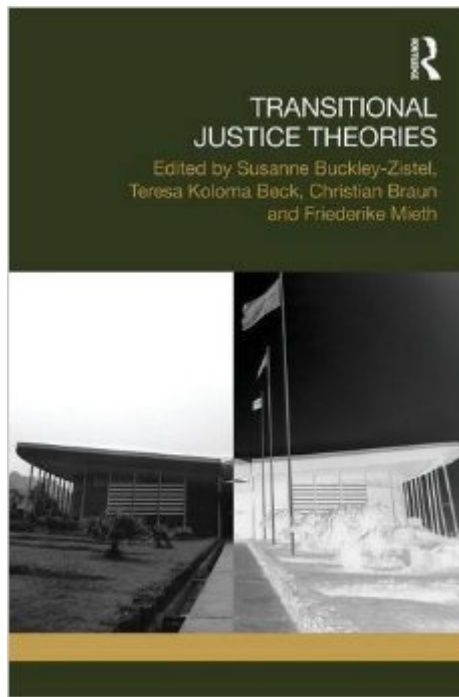

Even though highly theoretical, the chapters provide an easy read for a wide audience including readers not familiar with theoretical investigations.
